## **DEPARTMENT HEAD REPORTS:**

**Jerald Hole, HW Superintendent** stated that there are many road cuts that were made in order to replace culverts on certain roads, in particular: Dunham, Babcock, and Emerick. Cutting the pavement is required to replace the culverts, put in crushed stone, and pack it. HW is hoping to get settling out of the roads before they are patched in and leveled. There are cones to indicate where work is being done.

**Supervisor Saraceni** said that Mr. Burkinshaw is at the first car show in Village Square. It is a continuing effort between Parks and Recreation and the Village of Baldwinsville (VOB) to bring more activities into the VOB.

**Supervisor Saraceni** recognized Brandy Litterbrant on his continued work with taking apart the old water meters. They were recently brought to recycling. TOL returned the scrap metal and received \$1,905.

**Supervisor Saraceni** mentioned the cell tower law, and how TOL is working with Municipal Solutions and the VOB. Municipal Solutions assist in negotiations for cell towers. The law requires an application fee for modifications, inspection process and procedures for same. Last week TOL took in the first \$2,005 non-refundable application fee for tower modifications. Through the process, TOL realized there was another provider operating without a franchise fee. Some of the things that were put into place are now paying dividends. Discussion of the "new" 5G Cell Tower law commenced.

**Comptroller David Rahrle** reported that TOL has received the notice of renewal for rates for Excellus, which are effective July 1. The increase is 1.5%.
