- 4. CHA will update the Town of Lysander Community Development Five (5) Year Plan.
- 5. CHA will present the community development five (5) year plan as required at a public hearing.

Deliverables:

- Complete Onondaga County Community Development 2023 Funding Request for a \$50,000 project
- Complete Onondaga County Community Development 2023 Funding Request for a \$150,000 project
- Updated town of Lysander Community Development Five (5) Year Plan

Assumptions:

• The Town of Lysander Clerk will publish the required public hearing notice in the local paper and provide proof of publication to be included in the grant application.
