Al Yager: This is near River Road and the old Bridge Street Crossing that will extend sewers to the Top Fabricators Facility. It does include a force main that is large enough to handle flow from the one residential parcel on what is Old West Bridge or Old Lamson Road and the old ice cream shop and the fire department. So, if they choose to extend the district further and contribute or participate, the Village of Phoenix has provided us with a letter stating that they are not opposed to it and have capacity to handle the additional flow from the one parcel that has been added to the West Phoenix Sewer District. This will benefit the residents in the fact that we are still paying the county to maintain the West Phoenix pump station. So, we will have one more residential, or one more commercial unit added to that, and we will reduce the cost for the West Phoenix Sewer District residents slightly just because they will be in the district, and more pay into the fund expenses.

Additional extensions would need to be approved by the Village. The Village's treatment plant does not have a lot of capacity left, so that may be more of a limiting factor.

There is no cost to the public. The applicant is paying all costs associated with it. So, this is just the legal procedure that we have to go through to be able to include the parcel in the taxing district. The Sewer District will actually lower the cost to the existing residents because we have one more unit paying towards the maintenance of the pump station. Then it is not an ad valorem district, it is a unit charge district.

Citizens Comments

Rob Helfrich of Coachman's Whip expressed his interest in the open Town Board seat and explained that he has been representing people from the town and has put a lot of time into it and included his credentials.

Sandy Baker of Sunset Terrace spoke about her decision not to pursue the Town Board seat, noting that she did not have an agenda, and that her interest in the position was genuine.

Fred Burtch of Plainville Road noted that he has been attending meetings since 2008 when he became aware of issues within the town. He discussed light pollution, traffic issues, and the location of the YMCA.

Several people in the audience spoke from their seats and made political statements. Those comments will not be included in these minutes.

Town Board Comments

Councilor Moore discussed the open Board seat and that the Board is seeking the best person for that position. He mentioned that he has been on the Board for three terms and that the negativity in the building comes from those who bring it in. Councilor Moore stated that the Board has business to do. He said others have mentioned that there should be more people attending meetings, but there's negativity that is brought in. He lectured Mr. Burtch on his past poor behavior, and how shameful it has been. Councilor Moore said that kind of negativity stops good people from wanting to become Town Board members and attending meetings. Councilor Moore was interrupted several times and Supervisor Rode interjected and stated that he has allowed public discussion for the first time in a long time and asked the audience to please not ruin it for everybody. He wants the public to come to the meetings and have a rapport with them. He reiterated: "Don't ruin it; I don't want to take it away; don't be the bad apple." He also stated that people should come up to the mic and address the Board.

Councilor Geraci and **Councilor Kudarauskas** mentioned the open Board seat as well and expressed that they would like to do what is best for the town.
