The stormwater website is successfully functioning as a municipal and public education tool based on the 16,927 total hits recorded during the permit year. The number of site users accessing multiple pages increased based on an approximate 19% decline in "unique" hits from the previous year (5,449 recorded in 2017-18 Vs. 4393 in 2018-19).

Syracuse Post Standard Stormwater Pullout: Develop a 4-page pullout to be distributed in the main section of the daily Syracuse Post Standard newspaper that focuses on stormwater processes, impacts, issues of concern, primary pollutants of concern, and citizen generated solutions.

B. Briefly summarize the observations that indicated the overall effectiveness of this Measurable Goal.

The pullout was published on April 17, 2018. As reported by the Post Standard, the insert reached 125,772 readers or 17% of the adults in a 7 county CNY distribution area, or 95,702 readers/26% of the adult population in Onondaga County.
