Citizens Comments

Fred Burtch mentioned the Madison County solar fire and concern for its residents who were relocated due to toxins. He said he attended public hearings on solar and researched same. He said the companies who spoke said it wasn't brought up as a topic. Supervisor Wicks noted that there could be a statewide moratorium in the future. Mr. Burtch mentioned the current solar farms on Lamson and Dinglehole, and others in Van Buren. He said the town should make sure the firefighters are prepared in an event something happens. Supervisor Wicks said the firefighters are trained in those types of matters, and Mr. Burtch said the solar farm wasn't taking the water.

Town Board Comments

Councilor Kudarauskas said he and Councilor Rode met with Budweiser to talk about the trucks on Brundage Road, and they found out there was a lack of communication with drivers on where to park. Budweiser is working with Lynn Tanner of Radisson regarding signage and flyers for the truck drivers.

Councilor Rode noted that rifle hunting was approved in New York State.

Supervisor's Comments

Supervisor Wicks met with the Van Buren Supervisor and Rachel May regarding the 631 bypass. She understands the problem and the County's plan, as the village is a choke point. There's an artery design that is being discussed. The only way to relieve the pressure on the village is to have a bypass. She is in favor of sending a letter to NYSDOT. Discussion ensued regarding Assemblyman Magnarelli, DOT issues and Micron. The feedback has been positive.

Department Head Reports

Tony Rivizzigno mentioned that a public hearing should be held regarding the solar moratorium extension.

Kevin Merrill, Parks and Recreation Director stated that there are many programs available, and the information can be found on the website. The spray park is open 10:00 AM to 7:00 PM. More programs include fitness classes, arts and crafts club, and sports related camps/day programs.

Councilor Geraci asked Mr. Merrill where the park is regarding projects, including the restroom renovations. Mr. Merrill advised that they are reviewing a grant, but there is not enough funding for what needs to be done on that building. He said parks is not immediately doing anything, and he will look into reapplying for the grant, as more bathrooms are needed. Councilor Geraci asked if there is a plan he is putting together. Mr. Merrill said no, but he will work on that. He said the pickleball court is done. Councilor Geraci asked about the spray park and attendance. Mr. Merrill said he is waiting for a vendor to call back about a valve that needs to be replaced, and regarding attendance, said that it's based on a guess. Monday through Friday, there are 100 or more kids a day at the spray park.

On the weekends he guessed approximately 400 or 500 kids. **Mr. Merrill** mentioned the Pickleball Tournament to benefit the Baldwin foundation in September. Discussion ensued regarding the tournament.

Ken Svitak, HW Superintendent was asked by **Supervisor Wicks** if the deer in the road was taken care of, and how deer in the Town of Lysander are handled. **Mr. Svitak** advised that the county was going to take care of it, if it is on a county owned road, and on a town owned road the deer would be dragged to the curb.

Dina Falcone, Town Clerk mentioned that hunting licenses went on sale August 1st. Doe permits are available and there is a limited supply of duck stamps for waterfowl hunting.
