Fred Burtch asked about the gate at the landfill. **Mr. Yager** was concerned the chain wasn't locked. Fred asked about the brush-hogging twice a year and asked about the monitoring. **Mr. Yager** said the wells have to be purged and run a lab work analysis which is about \$4,000. He mentioned bailing the wells and they haven't seen any hits on contamination. It's a DEC requirement for closure of the landfill.

Mr. Burtch asked questions regarding solar projects and the past solar farm fire. He mentioned solar fields with a direct connect system and related it to homeowners or small businesses who cannot direct connect to the line. He asked if the moratorium covers industrial businesses and homeowners who might have solar panels. **Supervisor Wicks** said they made a change for the moratorium per Section 102 of Town Code which will include everything. He added that they would be grandfathered but that can be addressed later. The Village of Baldwinsville has their own code.
